AGREEMENT

Participation in the Mid-Maine Chamber of Commerce **Chamber Advantage** program is subject to the following terms:

- Before the Chamber is able to offer a **Chamber Advantage** discount or benefit, it must be contracted in writing by the Chamber member business offering the discount or benefit, using this form.
- The Chamber member offering the discount or benefit must be and remain a member in good standing of the Mid-Maine Chamber of Commerce.
- The discount or benefit must be of value and offered to the Chamber membership exclusively.
- The Chamber member business offering the discount or benefit may only offer this discount or benefit during the contracted time period.
- The Mid-Maine Chamber of Commerce may advertise, publicize and make available as part of its membership program, the **Chamber Advantage** discounts or benefit described in this Agreement.
- The Chamber member business agrees to indemnify, hold harmless, and release the Chamber from any liability arising out of the offering and purchase of service and/or goods under the **Chamber Advantage** program.
- Businesses can change their benefits up to two (2) times a year.
- Only two (2) discounts per business can be offered at one time.
